



SECURE CERTIFICATE OF INDIAN STATUS (SCIS) APPLICATION FOR ALREADY REGISTERED PERSONS ADULTS (16 OR OLDER), CHILDREN (15 OR YOUNGER) AND DEPENDENT ADULTS

Privacy statement

Personal information is collected, used and disclosed by Indigenous Services Canada in accordance with the [Privacy Act](https://laws-lois.justice.gc.ca/eng/acts/P-21/) (https://laws-lois.justice.gc.ca/eng/acts/P-21/). Only information needed to administer the Indian Registration and the Secure Certificate of Indian Status programs is collected. The authority to collect and use personal information is derived from the [Indian Act](https://laws-lois.justice.gc.ca/eng/acts/i-5/) (https://laws-lois.justice.gc.ca/eng/acts/i-5/). The information collected is used to determine entitlement to registration on the Indian Register and membership in a First Nation whose membership list is maintained by the Department, to issue a Secure Certificate of Indian Status to registered persons and for the provision of benefits and services to those who are registered. Section 7: Declaration and signature

Note: Failure to sign and date the declaration will delay application processing.

Notice to applicants: The Secure Certificate of Indian Status (SCIS) remains at all times the property of the Government of Canada and must only be used by the person in whose name it is issued. Any false or misleading statement with respect to this application and any supporting document, including the concealment of any material fact, selling or permitting the use of your SCIS by any other person or agency, is cause to revoke or refuse to issue an SCIS, and may lead to criminal prosecution.

Declaration: I request that a Secure Certificate of Indian Status (SCIS) be issued to me (or issued to the child or dependent adult on whose behalf I am applying) and solemnly declare that the information provided with respect to this application and any supporting document is true. I declare that the photo has not been altered and is a true likeness of me (or is a true likeness of the child or dependent adult). I have read and understand the Notice to applicants and the Privacy statement. I understand that as soon as I receive my new SCIS, I am to destroy and discard the old one.

If applying to replace a lost, stolen or damaged SCIS: I declare that I have not given my SCIS to another person or disposed of it in an unauthorized manner. I understand that an SCIS reported lost, stolen or damaged is no longer valid and can no longer be used. Should I regain possession of my SCIS, I understand that I am to destroy it immediately.
